## MARTHAM INCLOSURE.

EXTRACTS from the Award of George Cubitt, Esquire, and Robert Cory, the Younger, and Nathaniel Palmer, Gentlemen, (the said George Cubitt and Robert Cory being two of the General Commissioners named and appointed in and by an Act of Parliament, passed in the forty-seventh year of the Reign of His present Majesty, King George the Third, intitled, "An Act for Inclosing and Draining cer-"tain Lands, in the Parish of Martham, in the County of Norfolk," and the said Nathaniel Palmer being the General Commissioner appointed by the said George Cubitt and Robert Cory, under or by virtue of the powers contained in the said Act, in the room of Thomas Glover Ewen, Gentleman, the other General Commissioner, named and appointed in and by the said Act) which Award bears even date herewith, and is to be deposited and kept in the parish church of Martham aforesaid.

ND WE, the said George Cubitt and Robert Cory, do further cer-Boundaries. It tify and declare, that we, and the said Thomas Glover Ewen, by examination of witnesses upon oath, and by other legal ways and means, inquired into the boundaries of the said parish of Martham, by which it appeared that the said boundaries were sufficiently ascertained and distinguished.

In the first place, We, the said General Commissioners, do hereby set Allotment to Spetut and allot unto the Special Commissioners appointed by the said act, cial Commissioners. the Banks, Drains, and Pieces of Land, next herein-after described-(that s to say:) FIRST-ONE BANK, marked No. 1, in the said map or plan of the said parish of Martham, hereunto annexed, being eighteen eet wide at the base, and four feet high, commencing near the boundry line dividing the parishes of Martham, and Repps with Bastwick, it a point distant about cleven yards from the North River, and proceeding first in an East and then in a North-East direction, to the North-East corner of the fifth allotment herein-after made to Mary Pollard, thence in a South direction, to the South-East corner of the first allotment herein-after made to John Barker Huntington, Esquire. AND we do hereby declare, that the said allotments are made to the said Surveyors of the Highways, as and for public sand, gravel, clay, and chalk-pits, and to the intent; that the said allotments may, for ever beleafter, be used by the said Surveyors of the Highways, and the proprietors of lands and estates, in Martham aforesaid, and their tenants, for the time being, as and for public sand, gravel, clay, and chalk-pits, for the use of the inhabitants of the said parish, and to be used there; and also for procuring clay for the daubing such houses, tenements, and buildings, as now, or shall hereafter, belong to the persons, to whom any land or ground shall be allotted, by this our award, their heirs or assigns, and in such other manner, and under such rules and regulations, as the said Surveyors of the Highways shall direct or appoint.

Allotment to Special Commissioners of Martham Green.

AND We, the said General Commissioners, do hereby assign, set out, and allot unto the said Special Commissioners, and their successors, in trust for the Lord of the said Manor of Martham, (according to his estate and interest therein, immediately previous to the passing of the said act) his heirs and assigns, and in trust for a common of pasture for all the proprietors of hereditaments, in the said parish of Martham, who, immediately previous to the passing of the said act, had rights of common on the waste lands, in the said parish, their heirs and assigns, ONE PIECE OF LAND, marked No. 219, in the said map or plan, containing by measure, five acres, one rood, and thirty-two perches, bounded by the road leading to the Church, called Black Street, by houses and land belonging to John Ensor, Francis Riddell Reynolds, Robert Ward, the Feofices of Martham Free-School, and William Rogers, respectively, towards the North, by land belonging to the Reverend Charles Boutell and Diana Creasey, respectively, towards the North-West, by land belonging to Nathaniel Hindle, Daniel Cockerill, William Rogers, and Thomas Francis, respectively, and an ancient lane, towards the East, by land belonging to James Bane, Thomas Francis, Thomas Rising, Richard Warner, John Cobb, William Garnham, John and Robert Church, John Moxon, and Harber Pettingill, respectively, towards the South, by land belonging to John Moxon and Thomas Crane, towards the South-West, and by land belonging to Harber Pettingill, the public road leading from Martham to Repps, and land belonging to Rebecca Benslin, towards the West and North-West, which

said piece of land surrounds about eighteen perches of land belonging to John Le Nain and Thomas Dixon, upon which stand two dwelling-houses and other buildings.

AND We, the said General Commissioners, do hereby order and direct, Directions respectthat the several private roads, herein-before described, shall be and remain ing Private Roads. of the breadth of eighteen feet; and that all the said private roads shall, for ever hereafter, be maintained in good repair and condition, by the several persons, who shall, for the time being, be entitled to take and enjoy the grass and herbage growing thereon; and that they shall place, and for ever keep in good repair and condition, proper stiles, bridges, and planks, upon the said private roads, where the same shall be necessary, for the accommodation of passengers, cattle, and carriages, passing and repassing thereon, such persons respectively maintaining, in good repair, the parts of the said private roads, on which they respectively shall be entitled to take and enjoy the grass and herbage, and placing and maintaining, thereon, such stiles, bridges, and planks, as are hereinbefore directed, except that the said William Wells, and the owners, for the time being, of his said mill, shall pay towards the repair of the said first and third private roads, as herein-before directed.

AND We do hereby order and direct, that the owners and occupiers, for Right of Passage to Lands not adjoining the time being, of such pieces of land hereby alloted, as do not adjoin any Public or Prito any public or private road, hereby set out and appointed, shall, for vate Road. ever hereafter, have a right of passage for themselves, and their cattle, and carriages, to and from the same, from and to the public or private road or roads nearest to the said pieces of land, through, over, and upon, the lands that lie between the said pieces and the said public or private roads.

AND We do hereby order and direct, that the several new fences, Respecting the ma-hereby directed to be made by the said several proprietors, in their said al-king of Fences. lotments, respectively, shall consist of ditches, four feet wide at the top, and three feet deep perpendicular, and of banks adjoining to such ditches, and formed of the earth taken from the same, and that the banks of such fences shall be planted with white-thorn layer, and that half-hurdles or thorns shall be set on the summit of such banks, and shall there remain, or if taken away or spoiled shall be from time to time renewed, during the space of three years next ensuing the date of this our award, and that such new fences shall be made on the land of the respective proprietors, who are hereby directed to make the same.

AND We do hereby order and direct, that the wet ditches hereby Respecting Ditches. directed to be made by the said proprietors, in their said allotments respectively, shall be and remain of the breadth of twelve feet at the top, and four feet deep perpendicular, and that the said ditches and fences hereby directed to be made, shall be made within twelve calendar months next after the execution of this our award.
